The total ending cash balance as of June 30, 2018, was \$2,769,831.00. The payroll for July 6, 2018 was \$72,357.00. Accounts Payable for June 2018 total \$224,913.00. Cash on Deposit as of July 16, 2018 is \$2,472,560.00.

## FIRE CHIEF'S REPORT

## **Vehicle Report**

The ambulance that was involved in the auto accident last month is at body shop in Elgin that specializes in emergency equipment. It is getting a new frame and front body parts. Their initial estimate is to have it completed in Mid-August. The patient cot in the ambulance also must be replaced due to the accident and has been turned into insurance as well. The truck is still out of service due to the broken rear axle part. All the parts finally arrived Friday afternoon and we hope to have the truck back in service at the end of the week. We borrowed an engine from Manhattan Fire two (2) times this month, for a total of nine (9) days, due to one of our engines being out of service due to mechanical issues.
