The payroll for January 15, 2021 was (\$120,971). Accounts Payable for January 2021 total (\$188,766). Cash on Deposit as of January 18, 2021 is \$5,178,842.

## FIRE CHIEF'S REPORT

Vehicle report – the tower is still down; the warrantee work has been done. There are other issues currently being repaired. Insurance covered half of the tow bill.

Facility report – Denny is working with the architect on projects at station 3. The kitchen is original from 2003 and the side door needs to be replaced.

Administration report – three firefighters passed their one year but have left for other departments. He is working with Metro on staffing but its hard to find people. This is a problem not only on the contract side but also the district side. He has had more conversations in 18 days with the Metro staff (Heidi, Ted & Gina) then the entire time with AMR.

### **DEPUTY CHIEF'S REPORT**

2019 incidents were 4596, 2020 incidents were 4749 which is 153 more than last year. Fire Marshal Brown was sworn in for his second term as President of the Illinois Fire Inspectors Association. False alarm fees for 2020 were \$3,280.00. Plan review fees for 2020 were \$7,550.00. Land Extraction fees for 2020 were \$52,573.65. Our 2020 educational Facebook posts reached 145,975 people.
