TREASURER'S REPORT

Treasurer's Report for October 31, 2019. As of October 1, 2019, the beginning balance was \$5,224,022.00. The total receipts were \$292,294.00. The total disbursements were (\$887,108.00). The total ending cash balance as of October 31, 2019, was \$4,629,207.00. The payroll for November 8, 2019 was (\$94,778.00). Accounts Payable for November 2019 total (\$323,556.00). Cash on Deposit as of November 18, 2019 is \$4,210,874.00.

FIRE CHIEF'S REPORT

Vehicle Report

The new Engine (63) is in service. The new ambulance (62) is scheduled for the state inspection tomorrow. It will be in service next week.

Lance continues working on the old vehicles. With the age of some of the vehicles getting parts has become difficult.

Facility Report

BC Randolph is making progress on all the facilities. Station 2 is having electrical problems because of its age.

Trustee Sauter asked about the outlets in the bay. The Foundation continues to have problems with them at the pancake breakfasts.

Chief Riegel replied an electrician has been out, all electrical lines and outlets are working properly. The problem is either they are overloading the outlets, or they are using a bad cooking unit which is tripping the circuits.

Administration Report

The 2020 budget is done after working with James Howard and Attorney Gilbert.

DEPUTY CHIEF'S REPORT

We currently have 34 buildings and/or tenant buildouts in various stages of construction. False alarm fees received to date are \$3,560.00, plan review fees are \$11,348.00 and Land Extraction fees are \$35,930.47.

FM Brown attended the IFIA Board of Directors meeting. He an DC Turner also attended a fire alarm class presented by the Illinois Automatic Fire Alarm Assoc.

In October we did 14 safety talks, we held a CPR class and installed 17 car seats.

For the month of October our total educational Facebook posts reached 6,711 people.

OLD BUSINESS

A. IFC 2018 Fire Code with Amendments

Fire Marshal James Brown stated the fire code amendments have been highlighted and are in the board packets. He will answer any questions.

Trustee Sauter – what are our neighbors doing?

Jamie provided a printout stating we are progressive with Manhattan and Homer Fire Departments.

Trustee Sauter – what will be the cost to a new home builder? Jamie stated the cost is approx. \$1.66 per square foot. On average an additional \$4,000.

DC Turner stated we had two (2) fire fatalities last year in residential dwellings. In Rural areas that would be a tanker box and very labor intensive with a low save rate.

While that is going on the district still gets calls for response.

With sprinklers it would be a small event therefore a small response.

Manhattan has the residential requirement, BC Randolph put a sprinkler system in the house he built.

BC Randolph stated he fully supports this as a homeowner with a sprinkler system. This is a great option for our community.

Trustee McCollum thanked DC Turner and Jamie for meeting with him and answering all his questions. He feels the Village looks at this differently and maybe some of the trustees could meet with them. Trustee Levey agrees with him and is on board with this.

Chief Riegel stated the Foundation donated \$28,000.00 to the Fire Department for the purchase of a new monitor.
