The total ending cash balance as of November 30, 2019, was \$4,227,751.00. The payroll for December 6, 2019 was (\$84,254.00). Accounts Payable for December 2019 total (\$325,153.00). Cash on Deposit as of December 16, 2019 is \$3,818,344.00.

## **Facility Report**

BC Randolph is finding more issues at Station 2 with the plumbing and electrical due to the age of the building (built in 1972). He's looking for solutions from an outside source.

### **Administration Report**

Our Andres contract was renegotiated for 2020 with our percentage down from 5% to 4 %. Chief Riegel was elected to the LCC executive Board.

The EPA clean up continues at the Amherst fire location. There is a meeting tomorrow with their insurance rep trying to recoup our costs with the spiller pay bill.

### **DEPUTY CHIEF'S REPORT**

We currently have 27 buildings and/or tenant buildouts in various stages of construction. False alarm fees received to date are \$3,560.00, plan review fees are \$11,798.00 and Land Extraction fees are \$40,192.80.

FM Brown was sworn in as the president of the Illinois Fire Inspectors Association. In November we did 15 safety talks, we held a CPR class and installed 10 car seats. For the month of November our total educational Facebook posts reached 6,990 people.
