There were 11 classroom visits to preschoolers for the Learn Not to Burn Program, and 24 visits to 1<sup>st</sup> grade classrooms for the Adopt a Firefighter program.

We submitted the OSFM Small Equipment Grant. Calls for 2020 so far are 399.
