# E. <u>Discussion on Dispatch Center</u>

Chief Riegel, Deputy Chief Turner and two Trustees met with the Director of Laraway Dispatch. Some of the issues she inherited, some are poor training. She is committed to correct the issues.

- Trustee Levey stated the simplest thing to do is to stay with them, but only if the problems can be corrected. It's unacceptable to put our people or the public in harms way.
- Chief Riegel stated Manhattan Fire is submitting their letter to leave on June 1<sup>st</sup> because they believe the problems won't be corrected.
- Trustee Sauter stated there needs to be a big improvement by the next board meeting or a decision needs to be made.
- Trustee Minger stated Frankfort and Manhattan fire are leaving, he asked council if we can submit a letter of intent to leave the dispatch center and if the service greatly improves can we withdrawal the letter?
- Attorney Tom Gilbert stated he will investigate this.

# F. Equipment Purchase for New Engine Chief Riegel requested \$25,000.00 for equipment and appliance fittings for operations of the Engine out of the Equipment Budget. And \$7,000.00 for hoses out of the Hose Budget.

A motion was made by Trustee DiFiori seconded by Trustee Sauter to approve the \$25,000.00 purchase of equipment and \$7,000.00 purchase of hose.

The controlled burn will be moved to the parking lot on Family Fun Day. The Foundation will be meeting with the district this Wednesday to discuss the specifics. There will be a planned giving presentation at the June meeting. There will be a reorganization of the board to be voted on at their June meeting.
