TREASURER'S REPORT

Treasurer's Report for August 31, 2018. As of August 1, 2018, the beginning balance was \$2,748,030.00. The total receipts were \$524,186.00. The total disbursements were (\$841,808.00). The total ending cash balance as of August 31, 2018, was \$2,430,408.00. The payroll for September 14, 2018 was \$67,983.00. Accounts Payable for September 2018 total \$224,713.00. Cash on Deposit as of September 17, 2018 is \$2,137,711.00.

Trustee Sauter stated that included in the disbursements of \$841,808.00 was a \$223,000.00 payment to the Pension. The cash on deposit of \$2,137,711.00 does not reflect the TAWS loan of \$750,00.000 being paid off yesterday. Our actual cash on deposit is 1.4 million which clearly shows why we need the referendum.

Trustee McCollum asked Chief Riegel when the TAWS loan would be paid back. Chief Riegel stated by paying off the loan early (yesterday) we saved \$2,000.00.

FIRE CHIEF'S REPORT

Vehicle Report

The ambulance that was involved in the accident in June has been returned to us. We still must replace a few parts for the cot retention system and should have it back in service soon. Engine 61 has been out of service for 3 weeks waiting on a replacement suspension part. The part finally arrived today and should be back in service by weeks end.

Facility Report

The ComEd Lighting grant has been completed and ComEd has done the audit of the grant.

Administration Report

We were awarded a FEMA Grant for 27 new portable radios. The delivery date is the first week of November. I would like to thank Lt Applegate and Marisa for their hard work on the grant, it would not have been possible without them.

DEPUTY CHIEF'S REPORT

Chief Turner reported we have received \$5,960.00in false alarm fees, \$15,057.50 in plan review fees and \$17,889.45 in land extraction fees. (all year to date). We have had 3,069 calls for service which is 341 more than last year.

The district received the 2017 Life Safety Achievement Award by the National Association of State Fire Marshals Fire Research & Education and Grinnell Mutual. We were one (1) of thirty-two (32) fire departments in the state of Illinois to receive this award.

- E. Station #1 Day Room Furnace Chief Riegel reported the boiler for the day room needs to be replaced. We have 2 to 3 failures a year. The cost to the district would be \$12,750.00. This will be taken out of Land Extraction Fees.
