The total ending cash balance as of December 31, 2015 was \$3,512,674.97 The payroll for January 8, 2016 was \$72,544.96. Accounts Payable for January 2016 total \$336,976.81 Cash on Deposit as of January 18, 2016 is \$3,103,153.20.
