# FIRE CHIEF'S REPORT by Deputy Chief Turner

#### A. Vehicle Report

- We sold Surpluses vehicles- 1997 Pierce Engine for \$4000, 1999 International Ambulance for \$2500 and a 2007 Ford Ambulance for \$4500. For a total of \$11,000.
   The 1997 Pierce had significant frame damage from rust which brought its value down significantly.
- We are starting to aggressively treat rust on frames of vehicles when they come in for preventive maintenance. The frame damage is becoming a huge concern in the Midwest due to the use of liquid salts and beat juice on the roads.

#### B. Facility

• Station 4's windows need to be replaced. The glass is separating from the frames, pictures are in your packets. BC Randolph is working on getting quotes to replace the windows and hope to have them for the next meeting.

# C. Administration

- Chief Engledow formerly served as the grant officer, going forward Marissa
   Schrieber and Brian Applegate will be doing it together. They both registered for a
   grant writing class in April and should be a nice complement to each other with their
   differing backgrounds.
- We are starting to look at different options to update our website to make it easier
  to update information on. We have a few different options on ways to do it and will
  be forming a committee to research it and make sure it has all the future needs. We
  hope to have something going by the first part of next year.

• The department is at 2945 call for service for the year and are 144 calls ahead of last year.
