FIRE CHIEF'S REPORT

Vehicle – we're still having problems getting parts. We had the Lemont engine here for a few days. It will take about nine weeks for the radiator for the truck to come in. The Manhattan reserve is holding up. The agreement we made to share vehicles really helps. We have been trying to replace staff vehicles for 2 years. Per legal counsel we'll put out an RPF and see what we get.

Facility – Station 3 landscaping and brick work are done. There was more damage than we thought with water eroding the conduit.

Administration – DC Turner will be leaving us in January. Congratulation from the Board of Trustees.

DEPUTY CHIEF'S REPORT

For the Life Safety Division, Marisa finished all three of the Sound Off program lessons. She Installed 8 car seats and certified 39 people in CPR.

August education Facebook posts reached about 15,712 people.

Inspectors Frawley & Donath are working in Station #1 & #3 still districts. Inspector J. Applegate is working on pre-incident surveys and following up on false alarms. Inspector Marianovich is working the Rt. 30 corridor doing annual re-inspections.

Currently we have 25 buildings in various stages of construction. We have 7 homes that require residential sprinklers.

False Alarm fees received \$8,984.85. Land Extraction Fees are \$26,017.78 to date.
