TREASURER'S REPORT

Treasurer's Report for October 31, 2017. As of October 1, 2017, the beginning balance was \$3,222,036.33. The total receipts were \$738,978.74. The total disbursements were (\$696,712.71). The total ending cash balance as of October 31, 2017, was \$3,264,302.36. The payroll for November 9, 2017 was \$81,124.46. Accounts Payable for November 2017 total \$464,633.09. Cash on Deposit as of November 20, 2017, is \$2,718,544.81.

FIRE CHIEF'S REPORT

Vehicle Report

- Truck 61 was out of service for two weeks this past month due to a coolant leak. The
 dealer determined that the issue was a bad upper tank on the radiator and has replaced
 it.
- Engine 61 came back from the overhaul but had a few outstanding issues still present, so it was sent back to the dealer.
- Ambulance 62 was out of service for three weeks at the dealer for warranty work due to starting issues. We just received it back today.

Facility Report

• The window replacement at Station 4 should be starting in the next week, weather dependent. We will be using land extraction funds to pay for the replacement.

Administration Report

- The department is at 3721 calls for service for the year and are 277 calls ahead of last year.
- We are also obviously seeing an increase in the amount of multiple calls for service. So
 far for November we have had 65 incidences where we have had multiple calls at the
 same time. In the same time frame last year, we had 40 times where we had multiple
 calls in progress. Last year we had 887 times where we had multiple calls in progress, to
 date this year that number is 959.

DEPUTY CHIEF'S REPORT

October was Fire Prevention month, we held our 2nd annual open house where residents are invited to stop in at the stations. We gave three (3) Firefighter Statues to our three partners: Chicago Dough, AMC Movie Theatre and Ranch Frosties.
