TREASURER'S REPORT

Treasurer's Report for November 30, 2016. As of November 1, 2016 the beginning balance was \$4,216,688.70. The total receipts were \$150,452.74. The total disbursements were (\$616,551.54). The total ending cash balance as of November 30, 2016 was \$3,750,589.90. The payroll for December 9, 2016 was \$74,880.17. Accounts Payable for December 2016 total \$345,448.10. Cash on Deposit as of December 19, 2016 is \$3,330,261.63.

A. Vehicle Report

- The two (2) vehicles that were struck while parked at Station #1 were a 2002 Suburban and 2006 Expedition both used by the Life Safety Division, they are both totaled. There is also damage to landscaping and exterior electrical. Some of the repair work can be done now some not until the spring. We are talking to the insurance companies so we will wait and see what happens.
- The two (2) new vehicles we purchased for that division were delivered the day after the accident, but this still leaves the department short two (2) vehicles.

B. Administration

• Next year is a hiring year for us so we will be working with the Commissioners.

C. Other

- Dan Turner just received the state designation of Fire Marshal, he is one of three (3) in the entire state of Illinois.

Attorney Tom Gilbert's preference is to go to bid, but if this is indeed an emergency situation this can be done.

Trustee Levey – you must obtain multiple prices from multiple dealers and present them to the vehicle committee for the final decision.

Trustee Minger – this will not be a cash deal. This will be paid for by either the insurance money or a loan thru a dealership.
