BC Randolph is still working with the vendor on the bathrooms at station 4. The flooring replacement at station 4 & station 1 are all done.

Administration Report

We recently hired six (6) district fire fighters and two (2) have resigned.

DEPUTY CHIEF'S REPORT

- Chief Riegel reported for Deputy Chief Turner, we currently have thirty (30) buildings and/or tenant build-outs in various stages of construction.
- Marisa did eleven (11) car seat installs.
- For the month of March our educational Facebook posts reached a total of 17,233 people.

- A. Discussion and possible action on Village Loan Repayment Chief Riegel and Accountant James Howard suggest the following options.
 - 1. 4-year repayment: \$100,000, \$100,000, \$100,000
 - 2. 5-year repayment: \$100,000, \$100,000, \$100,000, \$100,000, \$150,000

C. Discussion on Laraway Dispatch

Chief Riegel presented twelve (12) calls to the Board that were incorrectly dispatched by Laraway. These calls all occurred in the past few months vs. 2 or 3 incorrect calls for an entire year with our previous dispatch center. The Lincolnway Chief's have met and discussed these issues. Us and Frankfort have the worst problem, but we also have more calls than the other fire departments.

Frankfort Fire Department is leaving Lincolnway Dispatch and moving to Orland Dispatch. Chief Riegel and BC Randolph met with Orland Dispatch there is no fee for them to do an assessment of our needs. They also met with Wescom Dispatch and they charge \$3,000.00 to do an assessment, if we choose to go with them that fee is deducted off the first month's invoice.

<u>Trustee Levey</u> – we have a new multimillion-dollar facility and can't get dispatched to the right location. After the problems are reported to the dispatch director nothing is being done to correct the problems. We seriously need to investigate other options.

<u>Trustee Sauter</u> – obviously the staff is poorly trained. We need to send a letter stating that things need to improve in thirty (30) days, by our next board meeting of May 20th.

<u>Trustee McCollum</u> – we have a zero tolerance for these kind of mistakes in this line of work.

D. Discussion and Possible Action of Engine Purchase
We received twelve (12) bids, after careful review our Apparatus Committee
recommends: Option A from Global Emergency Products (Pierce) for \$488,441.00. They
met 100% of the RFP requirements and the lowest bidder.

A motion was made by Trustee Sauter seconded by Trustee McCollum to approve the purchase of an Engine as bided: Option A from Global Emergency Products for \$488,441.00.

E. Discussion and Possible Action of Engine and Ambulance Loans

We received two (2) loan term sheets as follows:

- 1. Old Plank Trail Bank
 - Ambulance Loan of \$350,000 for 3 years @ 3.85% or 4 years @ 3.9%
 - Engine Loan of \$550,000 for 6 or 7 years @ 4.0%
 - Total of both loans not to exceed \$850,000
- 2. Town Center Bank
 - Ambulance Loan of \$300,000 for 3 or 4 years @ 3.75%
 - Engine Loan of \$600,000 for 7 years @ 4.24%

Chie Riegel met with Accountant James Howard and recommends:

Old Plank Trail Bank

Ambulance Loan for 4 years @ 3.9%

Engine Loan for 7 years @ 4.0%

Note: We will save \$3,800.00 over all

A motion was made by Trustee Sauter seconded by Trustee McCollum to approve the Ambulance and Engine loan financing with Old Plank Trail Bank.

He thanked the Trustees for their support and the district for helping with the Raffle. Their next project will be the controlled burn which they are discussing moving to Family Fun Day held at Station 1.
