The total ending cash balance as of March 31, 2016 was \$2,212,634.80. The payroll for April 1, 2016 was \$71,886.45. Payroll for April 15, 2016 was \$72,689.65. Accounts Payable for March 2016 total \$332,534.73. Cash on Deposit as of March 21, 2016 is \$1,735,523.97.
