TREASURER'S REPORT

Treasurer's Report for April 30, 2017. As of April 1, 2017, the beginning balance was \$2,100,689.85. The total receipts were \$164,120.16. The total disbursements were (\$540,160.45). The total ending cash balance as of April 30, 2017 was \$1,724,649.56. The payroll for May 12, 2017 was \$90,435.07. Accounts Payable for May 2017 total \$418,693.92. Cash on Deposit as of May 15, 2017 is \$1,215,520.57.

FIRE CHIEF'S REPORT

A. Vehicle Report

• The new Ambulance arrived. It will be sent out for lettering on May 16th, 2017. It will be ready for service in four to six weeks.

B. Facility

• The kitchen contract has been signed, and work has begun.

C. Administration

- Public Education Coordinator Marisa Schrieber attended a training course and is now a certified Youth Fire Setter Interventionist.
- The Life Safety Division received \$1,000.00 in false alarm fees for the month of April. This brings their year-to-date collections up to \$4,700.00
- The NLFPD Facebook page has reached 2,500 followers

D. Other

 A patient with a dislocated hip wrote a positive Facebook post about the excellent care he received from our paramedics. He also brought cookies in to the crew as a Thank You.

OLD BUSINESS

Trustees were advised by counsel to re-sign the addendum agreement with the State of Illinois for the intersections of Route 30 and I-80 entrance and exit ramps. No vote is needed, as the original addendum was signed and voted on in 2013.

NEW BUSINESS

A. Resolution #17-01 Surplus Equipment

Lieutenant Havener requested to surplus six (6) MSA air packs, one (1) MSA RIT pack, and spare MSA 4500 PSI air bottles that the District is no longer using. Chief Engledow stated that the District exclusively uses Scott air packs, and does not use MSA air packs. He stated it is unsafe for firefighters to conduct operations with two different types of air packs. Trustee McCollum asked if the intention was to sell the MSA air packs, Chief Engledow responded yes.

A motion was made by Trustee Sauter, seconded by Trustee McCollum to pass Resolution #17-01 to surplus the listed air packs.

B. IO Solutions

Chief Engledow explained the Commission is required to run an Eligibility Test every two years to maintain a list of firefighters to potentially hire on the District. Last time, the Commission conducted the interviews. Chief Engledow and the Commission recommend contracting IO Solutions to conduct 45 interviews for this test. Cost of three (3) days of interviewing for 45 candidates is \$6,240.00

A motion was made by Trustee Levey, seconded by Trustee Sauter to approve the payment of \$6,240.00 to IO Solutions to conduct interviews for the 2017 Eligibility Test on behalf of the Commission.

Mr. Marty Terlep relayed that the Commission had a meeting on May 9, 2017 with their attorney. Preference points, written test, and orientation were discussed for the Eligibility Test. The agenda format and the Rules & Regulations were updated. Next meeting is August 8, 2017.

FOUNDATION REPORT

Trustee McCollum reported that meetings began last week for the Controlled Burn Beef Cook-Off. The Foundation is actively pursuing cookers and sponsors at this time. Discussions for the 50/50 Raffle at this year's Village of New Lenox Triple Play Concert Series also took place at last week's meeting.

Trustee Sauter – It appears we are doing well out in the field. Keep up the good work.

Trustee McCollum – I met with a contractor for the kitchen remodel and was very impressed with the company. They were the lowest bidder, and reflected great quality work.

Trustee Levey – I have nothing.

Trustee Minger – In your packet, please look at what committees you are on. We tried to place our Trustees on committees according to what strengths they can bring the taxpayers. We are down to \$1.2 million, but we've done an outstanding job with the money we have to work with. Bill and Tom D., please take the next four (4) months to investigate alternative funding and report back to the Board at the October meeting. Also, come up with some cost-cutting measures. We need to make sure we explore all avenues of alternative funding before taking any other measures.
