TREASURER'S REPORT

Treasurer's Report for June 30, 2017. As of June 1, 2017, the beginning balance was \$1,679,251.03. The total receipts were \$2,119,494.42. The total disbursements were (\$616,264.71). The total ending cash balance as of June 30, 2017, was \$3,182,480.74. The payroll for July 7, 2017 was \$89,382.27. Accounts Payable for July 2017 total \$587,751.05. Cash on Deposit as of July 17, 2017, is \$2,505,347.42.

A motion was made by Trustee Levey seconded by Trustee McCollum to approve the Treasurer's report as given and pay the outstanding bills for this month.

SECRETARY'S REPORT

A motion was made by Trustee McCollum second by Trustee Minger to approve the minutes of the Public Meeting of the Board of Trustees of the New Lenox Fire Protection District on Monday, June 19, 2017.

FIRE CHIEF'S REPORT

A. Vehicle Report

• Lance is doing P.M.'s at the new shop. He's been there one (1) year now and things are going well.

B. Facility

- The kitchen at Station #1 is half done. Cabinets should be installed this week. We are happy with the work done so far. The village inspector has been out and everything passed.
- Everything is pretty much done with the upstairs insurance claim. The replacement lights are in, the electrician should be here this week.

DEPUTY CHIEF'S REPORT

- A. The National Safety Council has recognized New Lenox as one of the Safe Communities making a difference for its residents in a recent publication. We work with the Village of New Lenox educating our seniors by providing many programs for them.
- B. We recently created an EMS survey that is provided to patients that we treat. Each month DC Turner randomly selects 20 EMS calls and mails them this survey. DC Turner presented two (2) returned surveys. ie "the paramedics were compassionate, courteous, considerate." "They explained each step of the procedures as they did them".

Trustee McCollum stated he was approached by a person over the weekend who was having a heart attack. Our medics arrived within minutes, while he was still on the phone with 9-1-1. He also stated we did an excellent job.

We will still have five (5) ambulances for the district.

FIRE COMMISSIONER'S REPORT

Mr. Jim Pitcairn reported about the testing process for the 2017 eligibility list. On line application opens on September 11, 2017 at 9:00 a.m. and remains open for two (2) weeks until September 25, 2017 at 12:00 p.m. The cost of the application is \$60.00. Orientation is October 2, 2017 at the Pipefitters Hall. The written exam is October 7, 2017 at the Pipefitters Hall. There will be forty-five (45) interviews conducted over a three (3) day period.

FOUNDATION REPORT

Trustee McCullum reported they had their annual reorganizational meeting in June. They are making changes to record keeping, retention and policies. Their Future plan is to get PayPal up and running. They need help with their website. They would also like to appoint a liaison with the Foundation and the Administration Office.
