The Monday meeting was called to order at 7:00 p.m. with a quorum present.

#### TREASURER'S REPORT

Treasurer's Report for July 31, 2018. As of July 1, 2018, the beginning balance was \$3,040,362.00. The total receipts were \$261,261.00. The total disbursements were (\$552,089.00). The total ending cash balance as of July 31, 2018, was \$2,749,804.00. The payroll for August 3, 2018 was \$73,827.00. Accounts Payable for August 2018 total \$224,913.00. Cash on Deposit as of August 20, 2018 is \$2,451,064.00.

Trustee Sauter stated that the 2017 annual Treasurer Report shows our revenue of \$6,510,238.00 and disbursements of \$7,936,904.00 with a deficiency of \$1,426,666.00. This clearly shows we need the referendum.

A motion was made by Trustee McCollum seconded by Trustee Levey to approve the July Treasurer's report as given and pay the outstanding bills for this month.

#### SECRETARY'S REPORT

Trustee Levey commented to be clear we have 36 Firefighters on the Kurtz Contract and 12 on the District.

### FIRE CHIEF'S REPORT

### **Vehicle Report**

The ambulance that was involved in the accident on June 8<sup>th</sup> is still at the body shop having the frame replaced. They hope to have it returned to us in early September.

Truck 61 is back in service after being out of service for a month and a half due to the broken rear suspension.

### **Facility Report**

Station 1 and 3's lots were seal coated this month.

The lighting update to the stations is complete. The total project cost \$41,808 and we were able to get a ComEd rebate of \$28,523.77 so the cost to the district was \$13,184.73. We should be able to recoup those costs in the first year due to the savings on the electrical bill.

### **Administration Report**

There is a meeting coming up this week to start the closeout of Lincoln-way Dispatch and distribution of the assets that they have. I will have more information in the next few weeks as to the process. We are 344 calls above this time last year.

#### **DEPUTY CHIEF'S REPORT**

Fire Marshal James Brown reported we have received \$4,760.00 in false alarm fees, \$11,707.50 in plan review fees and \$11,545.52 in land extraction fees. (all year to date).

### FIRE COMMISSIONER'S REPORT

- The I-Chiefs completed the testing process for Battalion Chief and Lieutenant and the Commission met to approve the merit points. The Temporary Promotion List was published. There is a ten (10) day waiting period for veteran's points to be submitted then the Permanent Promotion List will be posted. The final list will be posted August 28<sup>th</sup>.
- We did have one (1) call off and in lieu of payment already made to the I-Chief's they conducted exit conferences with each candidate, which they said was very helpful.

- The draw back with the I-Chief's is the written test. There were four (4) books to study for the test, one book alone was 400 pages. Nobody passed the written test. All four (4) BC candidates scored in the 50's when 70 was passing.
- With merit points given for education Michael Parkhurst is number one on the BC list and Zach Cook is number one on the LT list, beating out Joe Ward by twenty-one-hundredths of a point.

#### **FOUNDATION REPORT**

Trustee McCullum reported the Foundation had a meeting and approved the request from Jim Pitcairn to donate \$4,000.00 to the referendum campaign. They had another successful 50/50 raffle and raised \$1,653.00 thanks to the volunteers Joe Levey, Tom Sauter and foundation members. They had the Control Burn cook off with the maximum number of sponsors but not enough cookers. There were so many conflicts with the date they are looking to change the date next year.
