The total ending cash balance as of January 31, 2017 was \$3,003,137.20. The payroll for February 3, 2017 was \$81,196.71. The payroll for February 17, 2017 was \$83,130.65. Accounts Payable for February 2017 total \$407,943.25. Cash on Deposit as of February 20, 2017 is \$2,430,866.59.

#### A. Vehicle Report

• Boiler at Station #1 went out again. It will not last another winter. But we are tight on money now, so it will have to wait.

claim is still open due to the weather. He predicts that will be finished in May. He
is looking into quotes for the canopy. Trustee Levey asked whose insurance paid
for the vehicle claim. Deputy Chief Riegel says our insurance pays it, then seeks
reimbursement from the other party's insurance.
