FINANCIAL PRESENTATON

James Howard from Gov. Accounting advised that at the last board meeting a \$750,000.00 tax anticipation warrant was approved. For the past three (3) years the fire district has been in a deficit and will operate in a deficit this year. We are the 4th lowest tax rate with the 6th highest EAV.

NEW BUSINESS

Trustee Minger stated we tried a referendum in 2006, 2009, 2011, 2014, 2018 all failed. This is not a threat but facts. This is a very difficult decision.

- A. Personnel Eliminate four (4) spots a day.
- B. Cost Cutting
 Cut Pub Ed events we will no longer take a vehicle out of service.
- C. Potential Closures
 We will close a station

By not filling an open position in the Administration Office, cutting special teams, recent changes to our health insurance coverage, cutting 6 contract positions, cutting the part time program and closing a station we can potentially save \$659,000.00

Recommendation by Chief Riegel is to close Station #2 to keep the best coverage of our response area.

A motion was made by Trustee Levey seconded by Trustee Sauter to approve the closure of Station #2.

Discussion by Trustee McCollum. Should we wait three (3) weeks until our next board meeting to make this decision so we would have time to have a meeting with the Referendum Committee?

Trustee Sauter – Waiting is only going to create a bigger deficit.

Trustee Levey – Waiting 30 days will only cause us to go deeper into debt. Nothing will change. Our responsibility is to protect the district.

Trustee Minger – The Referendum committee is not sitting here or voting on this. The people sitting in this room are waiting for answers. We will schedule a meeting with the referendum committee to discuss our plan for the next election.

TRUSTEE COMMENTS

Trustee Levey - I never thought I would see this day. I am disappointed, but so proud. We need to focus on still doing our best and move forward and continue our hard work. The board couldn't be prouder of the union and all the work they do every day. Just remember what we are up against.

Trustee Sauter – I echo Trustee Levey's comments. We're not going to quit, but try in November to get the referendum passed so we can reopen station #2 and try to open another one.

Trustee McCollum – I expected it would pass and feel we have a great chance to do it in November.

Trustee Minger – Thanked everyone for everything they have done, but the voters said no. Station #2 will be closed temporarily hopefully. Thank you so much.
