WHEREAS, the Board of Trustees (the "Board") of the New Lenox Fire Protection District, Will County, Illinois (the "District") deems it advisable and in the best interests of the District and its residents to continue to provide fully adequate fire and emergency medical services to and from points inside and outside of the District; and
